PSIA-E/AASI - IN-HOUSE LEVEL I EXAMS

Our **In-House Level I Exam** service is a valuable and convenient service we offer to accommodate the needs of our snowsports school managers and their instructors desiring to become PSIA or AASI Level I Certified.

IN-HOUSE LEVEL I EXAMS DO:

- ✓ Serve snowsports schools that are not conveniently located near scheduled events.
- ✓ Allow new members to take the Level I exam in a cost effective and convenient manner.

IN-HOUSE LEVEL I EXAMS DO NOT:

- ✓ Take the place of a snowsports school's regular training program, or the 50-hour teaching/training requirement.
- ✓ Serve as a re-up clinic for current certified members.

Season 2009-2010 - FAQs

PARTICIPATION – Each participant must be a registered member. If they are paying for registered member dues at the same time as paying for the In-House Level I event, the registered member dues for this season are \$109. The “membership year” runs from July 1, 2009 - June 30, 2010 (June 30, 2011 if joining after February 15, 2010) and dues are non-refundable.

STEP 1: HOW TO SCHEDULE AN IN-HOUSE LEVEL I EXAM:

Submit the attached request form **at least 6 weeks before** the date you want to schedule your In-House Exam. If you have questions, contact Eileen Carr at (518) 452-6095 X111.

STEP 2: WHAT HAPPENS NEXT?

1. We will confirm your date, etc. and send you a packet via fax or e-mail which includes information about your specific event, as well as one copy of the paperwork required for each of the participants in your event to complete.
2. Each participant must complete the necessary form and return it to you with their full payment (as appropriate for event & registered member dues) by a deadline date which you should set. Your deadline to participants should be based on the deadline you are provided by the office of when we require all of your paperwork in the PSIA-E/AASI office. The event (and dues) payments from each participant should be paid to you/your resort. PSIA-E/AASI requires one check or credit card payment for the total due from ALL participants made out to PSIA-E/AASI from you or your resort, by the deadline.
3. As the event administrator, you must complete a coversheet which will also be supplied in the packet we send you. Please note the column for the date of birth (DOB) of each participant. DOB for each new member is very important for our records. Please be sure this column is completed to assist us. You need to fax this completed Event Roster/Coversheet as well as one participant form for each name on the roster - by the deadline date you are given. Your payment for ALL participants should follow this fax as promptly as possible.
